NOTE ABOVE ALL OFFENCES LISTED CARRY A MINIMUM + 1 Suspended Good Behaviour Ban. EG Contrary Conduct, Training, Dissent, First Offence, Grade 2, is read as Early 1 Match ban + 1 Suspended On condition of Good Behaviour.

Failure to meet the good behaviour standards will see the Suspended Penalty Applied to the Player

This matrix is a guide only, to help the Disciplinary Review Panels ensure consistency. The DRP is always encouraged to take all circumstances into consideration and use their discretion.

In all cases, when a player is reported, the case is reviewed, if it has merit, the DRP is stood up. Based on the evidence supplied, the DRP can issue one of the following grades:

Alt Grade	Meaning
Inconclusive Evidence	Player may be guilty, however, the evidence is not enough to warrant a sanction
Penalty Sufficient	The player has already served a sufficient penalty
Nothing to Answer	The is enough evidence to conclude the player did nothing wrong

If, after grading, and the grade carries a charge, determine the number of offences committed in 2025 to date, and determine the baseline penalty.

Produce documentation supporting the reasoning, including the charge, and present to the MPIO.

The MPIO or Registrar and Support Squad member will deliver the outcome of the Process to the player and the players parents, and they will be encouraged to take the early plea.

In the case the player wishes to contest the charge, the Panel will reconvene and the player will have the opportunity to plead their case. The panel will review and determine a new outcome.
